Product description

Seamate SB 33 is a high build self-polishing antifouling based on specially formulated organotin polymer as binder. This binder dissolves slowly in seawater so that fresh antifouling is continuously exposed.

Recommended use

As an antifouling for side and flatbottom areas on vessels operating at medium speed with drydocking intervals up to 60 months.

Surface preparation

Coated surfaces

Prior to paint application, all surfaces should be clean, dry and free from contamination. Remove surface contamination by high pressure fresh water cleaning. To be applied on a clean, dry approved primer/undercoat or intact self-polishing antifouling. Remove surface contamination by high pressure fresh water cleaning.

Other surfaces

The coating may be used on other substrates. Please contact your local Jotun office for more information.

Condition during application

The temperature of the substrate should be minimum 3°C above the dew point of the air, temperature and relative humidity measured in the vicinity of the substrate. Good ventilation is usually required in confined areas to ensure correct drying.

Application methods

Spray	Use airless spray
Brush	May be used but care must be taken to achieve the specified dry film thickness.
Roller	May be used however when using roller application care must be taken to apply sufficient material in order to achieve the specified dry film thickness.

Drying time

Drying times are generally related to air circulation, temperature, film thickness and number of coats, and will be affected correspondingly. The figures given in the table are typical with:

- * Good ventilation (Outdoor exposure or free circulation of air)
- * Typical film thickness
- * One coat on top of inert substrate

1. The interval indicates the time which normally occurs in a drydocking situation where the drying time depends on the total film thickness of primer/antifouling applied. The drying time will increase with increasing film thickness.

2. The surface should be dry and free from any contamination prior to application of the subsequent coat.

The actual drying time/times before recoating may be shorter or longer, depending on film thickness, ventilation, humidity, underlying paint system, requirement for early handling and mechanical strength etc. A complete system can be described on a system sheet, where all parameters and special conditions could be included.

Recommended type of primer:

Jotamastic 87 with tie coat, Vinyguard Black/Brown, Vinyguard Silvergrey 88, Safeguard, Safeguard Universal.

Storage

The product must be stored in accordance with national regulations. Storage conditions are to keep the containers in a dry, cool, well ventilated space and away from source of heat and ignition.Containers must be kept tightly closed.

Handling

Handle with care. Stir well before use.

Packing size

20 L. Packing may vary from country to country according to local requirements.
