Penguard Stayer is a two-pack high build epoxy coating with micaceous iron oxide. This product is a part of a complete system which is certified not to spread surface flames.

Recommended use

As primer or intermediate coat in an epoxy system on steel structures. Penguard Stayer is designed to give good adhesion at long recoating intervals.

Surface preparation

All surfaces should be clean, dry and free from contamination. The surface should be assessed and treated in accordance with ISO 8504.

Cleanliness: Blast cleaning to Sa $2\frac{1}{2}$ (ISO 8501-1:1988). Roughness: using abrasives suitable to achieve grade Fine to Medium G (30-85 μ m, Ry5) (ISO 8503-2)

Coated surfaces

Clean, dry and undamaged compatible primer. Contact your local Jotun office for more information.

Condition during application

The temperature of the substrate should be minimum 10°C and at least 3°C above the dew point of the air, temperature and relative humidity measured in the vicinity of the substrate. Good ventilation is usually required in confined areas to ensure proper drying. The coating should not be exposed to oil, chemicals or mechanical stress until cured. If necessary, Penguard Stayer, Penguard Primer, Penguard HB, Penguard Special may be used down to 2°C, provided a special accelerator is added.

Application methods

Spray Airless spray

Brush Recommended for stripe coating and small areas, care must be taken to achieve

the specified dry film thickness.

Application data

Mixing ratio (volume) 4 parts Comp. A (base) to be mixed thoroughly with 1 part Comp. B

(curing agent).

Mixing ½ hour prior to use.

Pot life (23°C) 8 hours. (Reduced at higher temp.)

Drying time

Drying times are generally related to air circulation, temperature, film thickness and number of coats, and will be affected correspondingly. The figures given in the table are typical with:

- * Good ventilation (Outdoor exposure or free circulation of air)
- * Typical film thickness
- * One coat on top of inert substrate

1 Provided the surface is free from chalking and other contamination prior to application, there is normally no overcoating time limit. If the coating has been exposed to direct sunlight for some time, special attention must be paid to surface cleaning and mattening/removal of the surface layer in order to obtain good adhesion.
