PRODUCT DESCRIPTION

An attractive matt finish, based on a blend of modern acrylic copolymers emulsion that provides a durable, washable surface with good color retention properties and resistance to yellowing and fading.

An easy to apply finish coat for interior and exterior surfaces including cement, plaster, concrete, brick, stucco, building boards and gypsum boards.

APPLICATION DATA

Thinning

Brush and Roller: 0 - 5% sweet water (The first coat may be thinned up to 10% on very absorbent surfaces).

Airless Spray: 0 – 10% sweet water.

Cleaning

Clean all tools and equipment immediately after use with clean water.

Caution

Do not use when humidity levels may cause surface condensation (maximum 85%), during rainy conditions or if temperatures are likely to fall below5°C during application and drying. Protect from frost.

SPECIFICATION

Preparation (New and Previously Decorated Surfaces)

General

All surfaces should be sound, clean, dry and free from loose and flaking material, dirt, efflorescence oil, grease, wax and polish. Where appropriate the relevant PATSA primer should be used. Fill small cracks and surface imperfections with PATSA AQUAFILL, larger cracks may be filled with Asocret RN. See notes [i, ii]

Exterior Concrete, Brick, Render, Plaster, Gypsum board, Fiber board, etc.

Prime with one coat of PATSA AQUAPRIME and allow drying. See notes [i, ii, iv]



Decoration

(New and Previously Decorated Surfaces)

All Surfaces

Apply two coats of AQUAMATT Emulsion. See notes [v, vi, vii, viii]

NOTES

i. Organic growth (moss, fungus, mildew.) should be treated with proprietary fungicidal treatments in accordance with manufacturer's instructions.

ii. On previously decorated surfaces, after the removal of loose and flaking material apply PATSA AQUAPRIME to bare areas overlapping onto the existing decoration.

iii. For the coating of non ferrous metals refer to PATSA technical service department.

iv. Surfaces of high porosity (very chalky and powdery) should be primed with one coat of ASO BA-FLEX diluted 1 : 1 with water.

v. For interior surfaces thin first coat to satisfy the porosity of the surface, a third coat may be required on very porous surfaces.

vi. A third coat may be required if there is a marked color contrast between the surface and the paint to be applied.

vii. On silk emulsion painted surfaces there is a possibility of cracking. Apply one coat of PATSA AQUAPRIME prior to finishing with PATSA AQUAMATT.
