### PRODUCT DESCRIPTION

A high quality decorative wall finish based on 100% acrylic copolymer emulsion with medium sheen / silky finish. Paint finish shows highly washable property, stain resistance, and resistance to yellowing.

# **USES**

Suitable for interior & exterior surfaces such as cement, plaster, concrete, brick, stucco, gypsumboard, building boards.

Particularly suitable in areas subject to condensation and wear & tear such as kitchens, bathrooms, corridors, hallways and public areas.

# **APPLICATION DATA**

Stir well before use. Apply by brush, roller, air spray or airless spray. For details of spray equipment, contact PATSA Technical Services Department.

# **Thinning**

Brush and Roller: 5% sweet water (The first coat may be thinned up to 10% on very absorbent surfaces). Air spray and Airless spray: 10% sweet water.

# Cleaning

Clean all tools and equipment immediately after use with clean water.

### **Caution**

Do not use when humidity levels may cause surface condensation (maximum 85%), during rainy conditions or if temperatures are likely to fall below 5°C during application. Protect from frost

# **Surfaces Preparation** (New and Previously Decorated Surfaces)

### **General**

All surfaces should be sound, clean, dry and free from loose and flaking material, dirt, efflorescence oil, grease, wax and polish. When appropriate the relevant PATSA Primer should be used. Fill small cracks and surface imperfections with PATSA AQUAFILL, larger cracks may be filled with ASOCRET RN. See notes [i, ii]

# **Exterior Concrete, Brick, Render, Plaster,** Gypsum board, Fiberboard etc.

Prime with one coat of AQUAPRIME. Allow to dry. See notes [i, ii, iii]

# **Decoration**

(New Work and Previously Decorated)

# **All surfaces**

Apply two coats of PATSA AQUASILK.

See notes [iv, v]



### **NOTES**

- i. Organic growth (moss, fungus, mildew) should be treated with a proprietary fungicidal treatment in accordance with manufacturer's instructions.
- On previously decorated surfaces, after the removal of loose and flaking material apply PATSA AQUAPRIME to bare areas overlapping onto the existing decoration.
- Surfaces of high porosity (very chalky and powdery) should be primed with one coat of **AOUAPRIME**
- iv. For interior surfaces thin first coat to satisfy the porosity of the surface, a third coat may be required on very porous surfaces. Do not use in heated surfaces.
- v. A third coat may be required if there is marked color contrast between the surface and the paint to be applied.

### **SAFETY INFORMATION**

Use only is well ventilated areas. In case of insufficient ventilation during spraying, wear suitable respiratory equipment. Do not breathe vapor / spray. In case of contact with eyes, rinse immediately with plenty of sweet water and seek medical advice. Keep out of reach of children.
