## PRODUCT DESCRIPTION

Uniprime-P is a solvent free primer coat based on a polymer dispersion to improve the bonding capacity of water containing polymer modified surface sealing finishes, paints and tile adhesives. By hardening the surface its load bearing capacity is increased. The pre-treatment with Uniprime-P prevents quick material looses in the water based products. Furthermore the pot life is increased and the danger of shrinkage cracking is decreased. To mark already primed surfaces, Uniprime-P is colored blueish.

## AREAS OF APPLICATION

Uniprime-P is used for absorbing and sanding surfaces such as gypsum construction materials (screeds, planks, and tiles), asbestos cement, concrete and masonry, with hardening and moisture stemming properties. It is also used as bonding bridge for surface waterproofing (such as Thermashield, Envirotect and other Bituminous products.
